

# Ski Salt Lake Official Rules

## 1. Sponsor.

MPI WEC Ski Salt Lake Giveaway ("Giveaway") is sponsored by Meeting Professionals International, 3030 LBJ Freeway, Suite 1700, Dallas, Texas, 75234-2759 ("MPI" or "Sponsor").

2. Giveaway Eligibility Period. The Giveaway period begins March 20, 2009 and ends on June 12, 2009 at 11:59 pm CDT. No entries will be accepted before or after the Giveaway Period.

## 3. To Enter.

Enter the Giveaway by registering for WEC 2009 at [www.mpiweb.org/wec09](http://www.mpiweb.org/wec09) or by sending an email to [giveaway@mpiweb.org](mailto:giveaway@mpiweb.org) listing your name, company name, address, and phone number. No purchase necessary to enter or win. VOID WHERE PROHIBITED. Automated or computer generated entries or mechanical reproductions are prohibited, and any use of automated devices or mechanical reproductions will cause disqualification. LIMIT: ONE ENTRY (PER GIVEAWAY) PER PERSON, HOUSEHOLD, FAMILY AND/OR E-MAIL ADDRESS, PER DAY. ### **5. Drawing; Odds of Winning:**
