


Chew tobacco

"Steve Murrin is making Fort Worth a Family Tradition"

At the age of four it had already become a family tradition to go with Dad to town - town being Fort Worth. There were always new faces to see, and his Dad would say, "I'd like you to meet my son, Steve Murrin. Someday he's gonna' make Fort Worth world famous." Folks would exchange jokes and tales about the old West and stories that are now part of Fort Worth's history. It was like listening to a bedtime story except you knew that what they were talking about had really happened. Steve soon could tell every major event by memory and cherished the fact that is Dad included him in these trips to town. Steve was well aware that these stories must be more than just idle chit-chat because of the little "history book" his Dad wrote into





every day to record these pieces of daily life. He learned a sense of respect and dignity about living in Fort Worth. His deep affection for the people that sacrificed to keep Fort Worth growing became more intense as the years passed by. Some people passing through Fort Worth only gave one day of their life to preserve its posterity. Others gave their whole lives: People like Steve Murrin and his father.

While some boys were shooting marbles by the curb and giggling at the young girls (not that Steve didn't do his share), Steve was filling in the picture of what he saw in his mind of the future based on the foundation of the past. He had an image to live up to passed on by his father and grandfather. The stockyards may have been a point of interest to the other kids in the neighborhood, but to Steve it was his home away from home. In time Steve grew up and went East to be educated at Holy Cross College in Massachusetts. He later transferred to the University of Texas and afterwards joined the Air Force.

When Steve came back to Fort Worth, a lot had changed. The stockyards were deteriorating and he determined then that they would be restored so they would provide a place for memories to be reborn, even if he had to do it singlehanded. He started out trying to bring about these changes the conventional way. After opening his own real estate business, he ran for county commissioner in 1970 but was unsuccessful. That was when he initiated the opening move to renovate the stockyards.

As I sat across from Steve and listened as he told how one by one he saw to it that buildings were purchased and leases were made to establish the preservation of the stockyards, I could feel much more than mere land transactions and contracts being signed. I sensed a part of Steve's history and lifestyle being kept alive to be shared with millions of tourists who would put Fort Worth down on their list of destinations to visit in Texas. He related his story to me with the same fervor and conviction that I can imagine his Dad did when Fort Worth was just a pimple on the nose of Texas' complexion.

One particular thing to be admired about Steve and his dedication to the rebirth of the Fort Worth stockyards is that he has allowed the imperfections to artfully mesh to create an appealing contrast. He is enjoying the achieving of his dream, knowing full well that there will be others in this decade and the decades to come that will add changes, some positively — some adversely, to the image he has in his mind. He may appear a little unconventional, but it is because he believes in keeping Fort Worth a family tradition.

Steve can be recognized in Fort Worth by his personal signature of a dashing and touchable mustache, "real" cowboy hat, jeans, shirt, boots, and real bandana scarf. You can usually find him at Billy Bob's (Worlds largest dance hall) set just as pretty as a stud in a saddle in the stock yards, or somewhere in the Cowtown Rodeo where he is self proclaimed mayor.

MPI gave Steve Murrin a special thanks for being its host in May, as an entourage of suppliers and planners visited Billy Bob's for a great time.

PROGRAM

Chapter members choosing this committee have the option of developing, planning, and executing "Monthly Programs" as well as assisting with arrangements for our monthly meeting. This committee is also responsible for the writing of the program notices and program recap reports for the VP-Public Relations.

MEMBERSHIP

Developing membership promotion and retention programs, the membership committee is composed of persons with an active pursuit toward the growth of the Chapter.

PUBLIC RELATIONS

Composed of at least six members, this committee plans and executes the public relations of the Chapter. The major responsibility of the committee is publishing *THE CURRENT*. NOMINATING
