Award nominations are not based on achievements in the 1984-85 year only, but for contributions that may have occurred over several years and have been consistently of a high quality.'

All of the panelists are veterans and will be expected to express strong opinions of the topic of ethics and professionalism in the meeting planning industry.



HOW DOES D/FW STACK UP?

A review of the membership statistics provided by MPI show that the D/FW Chapter ranks right in the middle on almost all accounts.

As of September 30, 1984, an analysis of the D/FW Chapter membership showed that 53% of the members are planners and 47% are suppliers. In Comparison, the Minnesota chapter shows a planner membership of an amazing 73.3%, while the Greater Orlando chapter currently only counts 43.8% of its members as planners.

In the matter of size, the major metropolitan areas show up as the largest chapters also. As of September 1984, the largest chapter was the Greater New York chapter with a huge membership of 738. Ranking second and third in size, were respectively, Washington, D.C. and Chicago. D/FW ranked well into in the top 10, reporting 234 members. The smallest chapter is represented by the 39 determined souls in the Canada/Manitoba Chapter.
