The DFW Chapter is starting the new 1986 - 87 year with a checkbook balance of \$4,156.13. Our July expenses totaled \$3,032.76, while our income was \$2,420.00. Our no show billings totaled \$19.00 for the month of July. If any members have outstanding invoices for "no show" status at monthly meetings, we would appreciate your payment.

New Roster Due October 1st

An updated D/FW Chapter roster will be sent to all members the first of October. This new roster will include all new members since the last printing. It will list alphabetically all members recorded as supplier status and those members recorded as meeting planner status. Two new additions to this roster will include a pictorial page with 1986 - 87 chapter officers and directors, as well as a reply card for members to forward changes of address and company affiliation.

June 1987 CMP Exam Work/Study Group

In preparation for the June 6, 1987 CMP exam, the D/FW Chapter of MPI will conduct weekly study sessions for members preparing for the exam. The study sessions will start in January 1987. Details regarding registration fee, location and exact dates will be outlined this fall by the Education Committee and presented to the membership for enrollment. Members planning on taking the June exam must submit their applications by March 20, 1987.

The exam includes 150 multiple choice questions based on 25 functions a meeting professional must perform under 17 different conditions. The exam will be scored on a pre-set pass/fail system, not a curve.

The Convention Liaison Council has taken a major step towards encouraging and recognizing professionalism in the industry by sponsoring the Certified Meeting Professional Program. This program is based upon professional experience and academic examination. Meeting planners have an oppportunity to work toward certification in a program which will encourage continuing education and industry participation, define new levels of professionalism, and recognize those who have achieved the standards of excellence which reflect highly in today's meetings and expositions industry.


