

Professional Education Conference in San Diego, December 8-10, the International Board of Directors convened and discussed, among other things, the prospects of changing the offi-

cial name of MPI. Should the "P" be changed from Planner to Professional?

After a lengthy discussion, the final vote was "yes", the issue was definitely worth presenting to the membership for their consideration. The supporters of the name change feel it would add a level of quality and professionalism to the organization name. Other members have expressed a concern over misrepresenting industry accreditation by assuming all MPI members have qualified for the CMP, CAE or CHSE recognition.

How does the Dallas/Ft. Worth Chapter feel about this issue? During the November monthly meeting, members were asked to express their preference. Of the 26 members who responded, 23 voted for "Professional" and 3 voted to retain the current "Planner" wording.

What is the next step in the final decision? Doug Heath, Executive Vice President of MPI International, reports that a ballot for members to complete will appear in the March or April issue of the Meeting Manager. Additionally, articles on "point" and "counterpoint" sides of the issue will be presented. All members need to read the spring issues of the Meeting Manager and thoroughly understand this issue, plus be sure to vote for your preference.

Once all ballots are received and tallied, the results will be presented to the International Board during the June 7-10 Conference in Winnipeg. If the membership votes to change the "P" to Professional, the Board will then reopen the discussion and if a consensus is reached, change the Articles of Incorporation to read Meeting Professionals International.

### FINALLY - MEMBERSHIP TRANSFERS SIMPLIFIED!

Report from International Board Meeting - December 6, 1986

Were you all as confused as we were about what happens to someone's membership when they move to a new position?

The International Board of Directors voted to amend the transfer policy, thanks to the hard work of the Membership Committee, which now reads as follows:

SECTION 4 - B "When a member changes employment from one organization to another, the member must notify MPI in writing. A dues renewal notice will be sent to the last known address annually. If a member does not renew within 60 days of the end of the dues period and want to rejoin MPI, he/she may do so by fulfilling all requirements for membership.

This amended policy is in keeping with the policy of MPI that states, "Membership in MPI shall be recorded in the name of the individual, not the organization.'

This means that you will keep your membership and be able to renew it on your regular "anniversary" date even if you move. However, the place you left may not replace you membership with another person, unless they fulfill the requirements for new membership. Changes in membership status were also clarified in the amended policy, as follows:

c. SECTION 4 - E: "A member of the planner c. SECTION 4 - E: A memoer of the group by group may transfer to the supplier group by fulfilling all requirements for supplier group

membership. If the planner was a previous supplier and had met the requirements for supplier membership and that membership has since been continuous, then the planner does not have to bring in another planner in order to change categories.


