September Executive Workshop Certifies 23 in CPR

Cardiopulmonary resuscitation (CPR) training and certification proved to be hot topics at the highly successful Executive Workshop held at the Omni Melrose Hotel on September 28, 1989. Held following the luncheon, the Workshop echoed the theme of September's monthly chapter meeting, "Handling Medical Emergencies," in a very practical way.

Skillfully taught by Donna Gurica, R.N., from The Southland Corporation, and Trey Davis and Jimmie Wesson, a CPR instructor and emergency medical technician, respectively, of Cost Reduction Technologies, the Workshop opened with an hour of general classroom instruction. Those participants simply hoping to brush up on old skills were surprised to discover that much of their original training has become outdated and replaced with new, more effective techniques.

Breaking down into groups, the class proceeded with individual "hands-on" training with Chris, the CPR mannequin, who never once complained as his chest cavity received one pounding after another. Ample time for hands-on practice with Chris helped give attendees confidence in their ability to perform in an emergency situation. Said one participant, "I always thought that I would be useless in a crisis. But after so much practice, I know what to do, and I'm certain I could and would do it!".

Certification was granted only after students passed both a written test and successfully demonstrated the proper techniques to instructors. Fully 100% of those taking part in the course were awarded certification.

Congratulations to those members of the DFW Chapter who earned or renewed their CPR certification at the September Executive Workshop!


