survey provided your board of directors vital information pertaining to your wants, needs and expectations for this coming year. The survey also confirmed that each volunteer serving on a


committee is doing a fantastic job in the areas of Achievement, Contribution and Teamwork.

### D/FW MPI to Help Dallas Get Ready for '94 World Cup Soccer

Dallas will be a part of soccer history in 1994. The United States will host World Cup Soccer for the first time and Dallas was selected as one of nine host cities for games.

As Dallas prepares for this worldclass event, the D/FW chapter of MPI is planning an informative program to learn about the economic impact of World Cup Soccer.

On Thursday evening, October 22, a panel of World Cup experts will address issues planners and suppliers should be aware of in order to prepare corporations and businesses for the impact of this once-in-a-lifetime experience! The meeting will take place at the Dallas Convention Center.

World Cup is a 24-team international tournament played once every four years in a single host country. The projected cumulative worldwide television audience for the 1994 World Cup Final is 30 billion and at least one billion will watch the World Cup Final live on television.

Dallas will host four games in the final round, one game in the round of 16, and one quarter-final game at the Cotton Bowl Stadium in Fair Park.

Dallas will be the official host city for the International Broadcast Center. This is the coordinating facility from which all outgoing television signals will be produced. Some 3,500 broadcasters and technicians will provide pictures and descriptions of the matches to audiences around the world.

It will take an incredible amount of energy to host 3,500 journalists and thousands of visitors from around the world. MPI can help you get started.

### The Buddy Program

"The 'buddy program,' chaired by Mary Cain (Texas Bundles), got off to a rousing start at the July chapter meeting," Smith said. "This new program enabled us to successfully pair 18 new members with 'buddies' who will help new members become acquainted with other chapter members, and introduce them to the many benefits available through their MPI membership." #### Orientation

O.D. O'Donnell (Nightlife Talent and Management Agency) will continue his leadership position as committee chair for member orientation.

"It is our goal to have every new — or not so new — member experience our orientation program," O'Donnell said. "This is an excellent opportunity to share important information about MPI in general, as well as specific details about our chapter programs. We stress that one of the best ways to derive benefits of membership is get involved through committee work."

### Recruitment

Catherine Mason (USMotivation) will serve as chair of the member recruitment committee. Utilizing all leads available, this committee will actively pursue new members for the D/FW chapter. It is also this committee's job to monitor the

planner/supplier ratio and assist in supplier/planner matchups when possible.

"Although we strongly encourage suppliers to find their own planner partner, we do our best to assist in this search. We currently have approximately 10 applications in our supplier pool needing a planner match," Smith said.

To abbreviate application processing time, all membership applications will be funneled through the vice president/ membership and/or the recruitment committee.

### Retention

Programs aimed at improving member retention will be the responsibility of Stan Heller (Silverleaf Marketing), chair of the retention committee.

"Stan, who served as vice president/ membership last year, certainly understands the challenges we face in this important area. It is the goal of this committee to reach the membership through direct mail, phone contact, and special programs to ensure that we are serving their needs," Smith said.

#### **Phone Tree**

In an effort to boost meeting attendance, the "phone tree" program has been revitalized. Through the phone tree, all chapter members will be contacted monthly to remind them of upcoming chapter meetings and other scheduled educational opportunities.

"Alice Roberts (Worthington Hotel), phone tree chair, and her committee face a challenging job. In order to contact all of our 480+ members every month, they are going to need a lot more help," Smith said. "If you can assist this important committee, please contact Alice at 817-882-1667 right away," Smith urged.

#### Prizes & Incentives

"Prize committee co-chairs, Charlotte Merrill-Davis (Event Source Professionals) and Bettie Smith (TI Product Center) have worked hard to come up with an outstanding program for the annual recruitment drive — Incentives that will really mean something to our members," Smith said.

Membership incentive awards and grand prize awards will be announced at the November chapter meeting, when the annual membership drive is launched.

"Although I cannot yet divulge specific details regarding the membership drive or the grand prizes selected for Planner, Supplier, and Recruiter of the Year, rest assured that these incentives and prizes will definitely motivate our members," Smith said.

Even though the various membership committees face challenges and "certainly have their work cut out for them," Smith feels confident that all goals are achievable.

"Membership does have its privileges, but the benefits can only be enjoyed by those who participate, so I encourage everyone to be mindful of the chapter slogan and 'Get involved! Get into the ACT!" Smith said.

### 'Buddy Program' — a "Welcome" Addition!

The "buddy program," which pairs an experienced, actively involved MPI member with a newcomer, calls for the experienced half of the team to stay in contact with the newcomer buddy for several months to keep him or her up-to-date on all chapter events and activities.

"We hope this buddy system will make new members feel more welcome at chapter meetings, and we see it as a valuable aid in improving our retention rate," said Mary Cain (Texas Bundles), buddy program chair.

"Having a buddy at my first meeting made me feel so welcome," said new member Rebecca Whitehead (Festivities). "It was nice to have someone introduce me to other members and to 'take care' of me."

July 's member orientation program had the largest attendance in recent history. Diane Smith, CMP (Alcon Labs), vice president/membership, attributes this success to the work of the member orientation committee, chaired by O.D. O'Donnell (Nightlife Talent and Management Agency). The committee made personal phone calls to new members, encouraging them to attend.

Cain hopes to see more members involved in the buddy program, and encourages interested persons to call her at 214-826-0184 to volunteer.

A long-time volunteer, leader and officer for the American Heart Association, Pennington knows what it takes to attract, retain and keep volunteers motivated.

After the luncheon Pennington will conduct an executive workshop on leadership skills. The Embassy Suites/Park Central area also has a boardroom, second floor conference suites, plus atrium function space for breaks or meals.


Embassy Suites/Park Central is situated at 13131 North Central Expressway. Explicit directions make getting there easy.

### Member Profile/Diane Smith Kansan's Path to Mosting

# Kansan's Path to Meeting Planning Not by Way of 'Yellow Brick Road'

For Kansas native and ace meeting planner Diane Smith, CMP (Alcon Laboratories, Inc.), D/FW MPI's vice-president/membership, meeting planning was never a goal, but a vocation that evolved after various intermediate career involvements.

Diane's journey to a career in meeting planning was "not by way of a yellow brick road," she says, alluding to another girl's famous journey from Kansas in *The Wizard of Oz*, but a magical journey of her own that took her from Kansas to Fort Worth with several stops — and a few bumps — along the way.

A youthful foray to Los Angeles — the goal of a teenager wrapped up in the music of the Beach Boys and "too much fantasy" — resulted in a short-lived marriage and "the best thing that ever happened to me — my daughter, Lisa Marie," Diane said.

Back home in Wichita, Diane worked in real estate development and met a "good 'ole Texas boy" with an appropriate Texas name. Soon, Diane was Mrs. Jerry Don Smith.

Her work in real estate development led to a career in construction in Overland Park — a job for which she says her childhood role as the oldest of five siblings was great preparation.

"All those years of telling my younger brothers and sisters what to do were great preparation for this job," she says with a smile. "Now I had several teams of construction workers to boss around!"

It took time, but she finally gained the confidence of all the woodworkers, electricians, plumbers, sheetrockers, and other construction specialists, and together they built housing projects throughout the greater Kansas City area.

"My 'dress for success' outfit was boots, jeans and a hard hat, and I loved it!" says Diane.

Life never has a dull moment for this foreman-cum-meeting planner. During those days of building housing projects for

others, Diane was building a "home model" — popularly known today as the "blended family" — of her own. Marriage to Jerry Don ("Smitty") brought three males into the lives of Diane and Lisa, with the addition of Smitty's sons, Keith and Craig.

A career opportunity for Smitty eventually brought the Smith family to Fort Worth. Diane worked for a while in construction with her Kansas contact but "the timing was lousy," and soon she was working a "temporary job" through Kelly Services.

That "temporary" job at Alcon Labs six years ago led to her current position and a career in meeting planning. Her immediate superior, Jack Weightman, convinced Diane that Alcon, a pharmaceutical company and international leader in ophthalmic research, was the place for her.

"Soon, I was planning meetings for the Vision Care Group and, again, I was able to do what I enjoy most — telling people what to do!" Diane says. "I have always been the designated planner for family reunions, ski trips, and other get-togethers, so this was a natural for me."

Diane attributes much of her success to Weightman, who "provided me the opportunity to soar." She recently moved into the area of Professional Relations at Alcon, handling a myriad of programs the company provides to schools of optometry and opthamology all over the



# D/FW Job Bank Initiates Aggressive New Program

Out of a job? Looking for a new challenge? Your first stop should be the job bank operated by the Dallas/Fort Worth chapter of Meeting Planners International.

Organized and staffed by a volunteer committee, the job bank is undertaking aggressive new programs to actively assist MPI members and others in the hospitality industry to gain greater access to job possibilities.

The job bank will accept applications from MPI members, and will actively seek information about job openings from companies, firms, and associations looking for meeting planning professionals.

"We encourage all sectors of the meeting planning and hospitality industry to post job openings. We will make every effort to match qualifications with job specifications, and will maintain a high level of confidentiality while doing so," said Marilyn McGuire, CMP (National Athletic Trainers Association), chair of the job bank committee.

The job bank, a program that has been operational for a number of years, operates under the direction of Alan Powdermaker (Circle R Ranch), vice president/finance, with the assistance of board member Carolyn Carey (Fidelity Union Life Insurance Company). Serving with McGuire are committee members Leigh Ann Rawls (American Heart Association), Barbara Rathwick (Journey House Travel), and Amanda Oglesby (The Aerobics Center).

New communications programs designed to encourage broader and more in-depth use of the job bank include publicizing the service regularly in the *Current*, by direct mail, and special handouts.

"We will also set up a special job bank table at every MPI meeting to display job openings," McGuire said. "It will be easy to find someone at every meeting to explain the procedures and activities of the job bank to potential users."

"The job bank committee is working actively to establish job bank awareness with companies, firms and associations needing employees in the meeting planning industry," said President Mary Cowart (Meeting Consultants).

MPI members wishing to register with the job bank should send a minimum of five typed resumes, along with a notation of any restrictions relative to distributing resumes, directly to McGuire.

The applications will remain "active" for eight months. The job bank will, within five days of receiving a job opening, send out all pertinent and qualified resumes in the active file. New resumes meeting the minimum job specificiations will be forwarded until the job opening is filled.

The processing fee for MPI members is \$15. Non-members may use the service for a \$25 fee.
