



# A Message from the President:

T-minus three months and counting.....

y o u r president ends and the rewards of chapter's pledge to "Impact the Legacy" will become evident. Just last month at midour

year retreat the Board of Directors met to evaluate our efforts to date and forecast the completion of this administration. Part of this selfexamination was to answer a series of important questions reflective of the first-half of 1999-2000:

#### 1. What did we accomplish?

Several areas of vital chapter interest were identified early on, including communications, administration and membership. Certain needs in each category were examined and the Board of Directors implemented action plans specific to these areas.

Communications: A completely redesigned and content-relevant newsletter has been produced with a new, 4-color masthead. The chapter web site, came on-line in August. The use of on-line event registration at the web site coupled with the new "Current" have provided an effective communications link to our members. A special quarterly breakfast program with chapter meeting planners, President-Elect Steve Kemble, Immediate Past-President Colleen Rickenbacher, CMP and me also has provided the leadership important knowledge on a variety of member interests.

Administration: This area has been greatly improved with use of the web site, but most of the significant strides have been accomplished by our Chapter Administrator, Randie Charnes, and the expanded services she provides to our members. Appraisals of the monthly meeting registration are at an all-time high, as are email

communications between the Chapter Office and the membership. Vice President of Finance Cheryl Beasley, CMP began a serious effort in July to financially restructure the chapter's business in terms of fiscal management. The result is a system of checks and balances which can govern the chapter for many years in a consistent and responsible manner.

Membership: Membership Tim Wade, CMP and board member LeeAnn Harle presided over the implementation of a thorough Member Needs Assessment Survey which attained record member participation. For the first time in many years, we have been provided a series of categorical recommendations on which to determine the direction this chapter will take over the course of the next few years, especially in the important areas of education, member services and chapter policy.

#### 2. What distinctive educational programs did we offer?

Three programs at monthly meetings were identified as particularly relevant, including the August program on Technology and the Web, the September meeting on TABC Laws and the Meetings Industry and the January meeting on Industry Advocacy with Dallas City Council member Laura Miller. Also of note was a team-building exercise in January at the Bass Pro Shops Outdoor World.

#### 3. What contributions to the local meetings industry did the chapter make?

This area is of particular interest, especially as MPI promotes industry leadership. The highly-successful Texas Education Conference held last November in Austin and coproduced by MPI D/FW, the MPI Hill Country Chapter and the Houston Area MPI Chapter continues to be a landmark event. MPI D/FW will host this conference in November 2000 at the Westin Stonebriar Resort. Our chapter's involvement in the Richland College Travel, Exhibition



and Meeting Management Programs in terms of scholarship and technology support was identified as an important contribution. Last month's Supplier Showcase at the Dallas Convention Center, the firstever in the chapter's history, also was noted.

#### And where do we go from here?

There is still much to be accomplished in the next few months. Most important is the transition from this administration to that of President-Elect Steve Kemble, who has an exciting vision for the chapter in 2000-20001. His newlyelected Board of Directors will 1 working in tandem with the current Board to position MPI D/FW for even greater accomplishments in the next

The successes of the next 90 days will ultimately determine if we were truly able this year to "Impact the Legacy!"





#### **NSF Checks**
